Dr. Weiss and Dr. Watson provide a framework for understanding why and how the justice system needs expert testimony and the instances where there is resistance to it. Unlike other books, which either treat the subject generally or in a prescriptive manner, *Psychiatric Expert Testimony: Emerging Applications* provides a foundation for practitioners to use available science and then to fashion their own work product. In this way, the expert is not held to a formula or format.
